Ernest again asked about maybe lowering the speed more since West Alexandria and Eaton has theirs at 35 mph outside of the actual Village and Michael said there are a lot of factors which don't meet the criteria in Camden. Another concern again was Douglass Street and the way people pull off that street. Kelly asked what the legal speed limit was on Central Ave. because it is posted 35 to 25 to 35 which is kind of confusing. He said he would have to contact ODOT to see what exactly it is supposed to be.

Committee/Staff Reports: Rusty reviewed his report with Council mentioning that with the money Council gave him for a snow plow and snow blower he was also able to get an enclosure for the gator with money left over. He had Buckeye Power separate the quote on the generator and switch gears and for both switch gears and the installation it would be \$15, 513.00 which is for the water plant and well field. Kelly said refresh my memory I thought we were looking at just generators for now - Rusty said that is the wastewater plant the switch gears are just for the water plant and the well field where as of now if the power were to go out one of us would have to come in and manually switch the generators on and when power comes back on we have to go in again to take the power off the generators and switch gears would do this automatically and eliminate someone having to come in. Ernest asked what the usage on our water supply and if it would be worth spending \$6,000.00 at the plant. Rusty said that would depend on any situation and how long the power is out and what kind of usage at the time would be. He said the pumps don't come on until the towner is at 132,000 gallons. Our daily usage right now is around 250,000 with not major leaks just a few residential ones. Ernest said I understand the wastewater plant because you have to keep it running 24/7 but the water plant you have reserves and it's going to give you time or 12 hours at least. Rusty said when the plant was built the only reason those weren't put in at that time was they were trying to cut corners due to the
