Toni made a motion to approve the minutes of the March 7, 2019 meeting. Debbie second the motion. Roll call. Kelly – yea, Debbie – yea, Toni – yea and Wendell – yea. Motion passed.

Public Participation: Kate Duskey asked Rusty who she needs to contact about the speed limit sign that was put in her yard. Rusty said ODOT and he would get her the number.
