REPORT FROM CHIEF OF POLICE

Powers received his pins from his wife Stephanie and Stemp received his pins from his Mother Terri. He also reviewed with Council a report showing all the department calls in 2019, 2020 and 2021.

REPORT FROM VILLAGE ADMINISTRATOR

Rusty updated Council on a few projects that have been completed. The work has been completed at the Sewer plant on the orbital shaft they are just waiting on a crane to put it all back together. Well #2 is cleaned and well #1 will be done within the next couple weeks. Christmas decorations are down and put away for the year. The tractor at the wastewater plant to we use to remove sludge from the drying beds and other things is done. I would like to get Council approval to purchase one. New are around \$25,000.00 but I know I can get a used one for less than that. Kelly made a motion to purchase another tractor with a spending limit of no more than \$20,000.00. Jeff second. Roll call. 5 Yea. Motion passed. Once we get the new one I will put the other on Govdeals. We did have a purchase of our old UV system for \$400.00 off Govdeals. Also discussed were some nuisance properties.

REPORT FROM FISCAL OFFICER

Becky said we are on the last process of putting our levies on the ballot. She presented Resolution #2038-2022 a Resolution Declaring it necessary to levy a tax for our general operating expenses at 4.00 mills (.40 cents) for 5 years as a renewal. Kelly made a motion to approve Resolution #2038-2022. Judy second. Roll call. 5 Yea. Motion passed.

Also presented was Resolution #2039-2022 a Resolution declaring it necessary to levy a tax for our Police Protections – Operating services at 6.00 mills (.60 cents) for 5 years as a renewal. Kelly made a motion to approve Resolution #2039-2022. Jeff second. Roll call. 5 Yea. Motion passed.

REPORT FROM DEPUTY VILLAGE ADMINISTRATOR

Ben presented a brief summary on the projects being worked on with the Strategic Planning (Live, Work, Play) and he would like Council to pass a Resolution just to show what we are prioritizing. Kelly made a motion to approve the 1st reading of Resolution #2040-2022 to approve the Strategic Planning projects. Judy second. Roll call. 5 Yea. Motion passed. Another economic development tool that he feels is essential is called Community Improvement Corporation which is a cost of \$4,500.00 to create it and he presented information in the portfolio as well. He also mentioned that the Village is partnering with a property owner to apply for a demolition grant which will be beneficial in the long run.
